Purpose

The System Board

The system board shall consist of one or more representatives selected by each of the boards participating in the regional system, and one or more representatives appointed by the county to represent territory not within the district of participating library board but within the territory of the regional system of cooperating libraries.

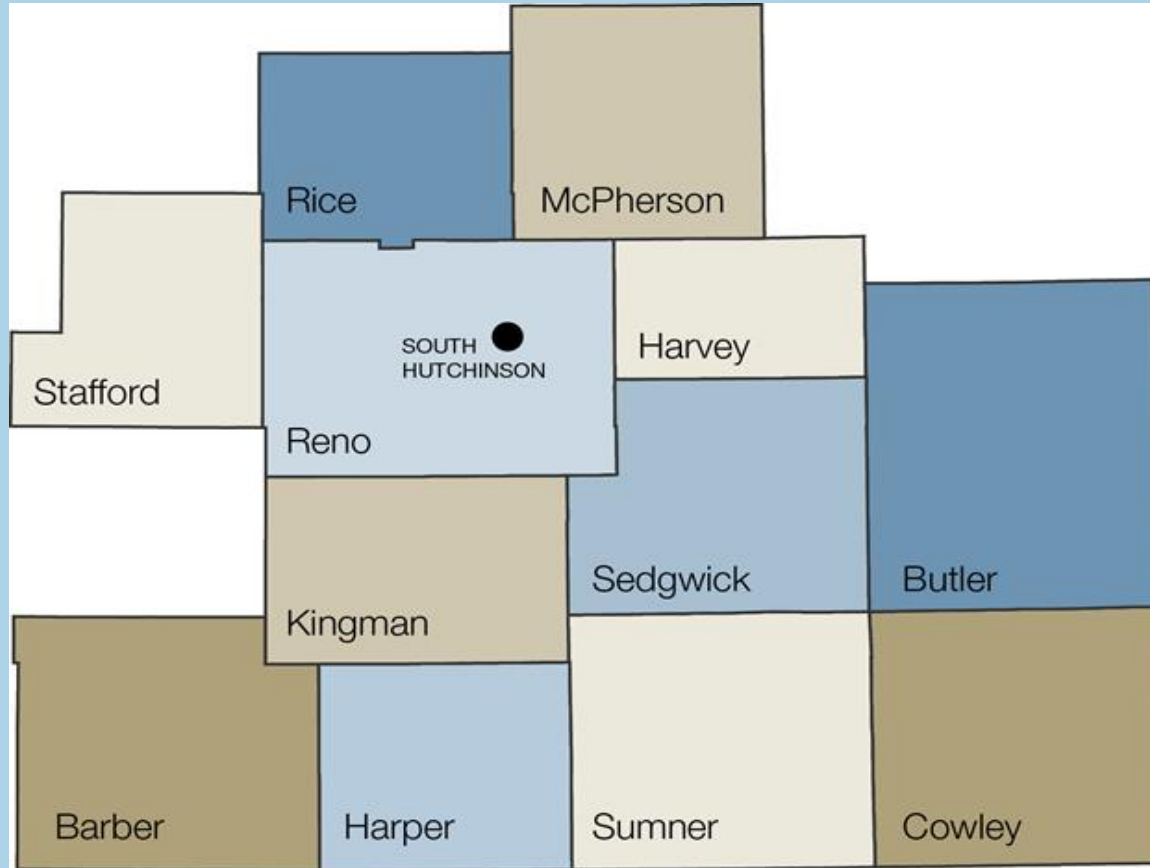
County Appointees

SCKLS Tax and Service Area



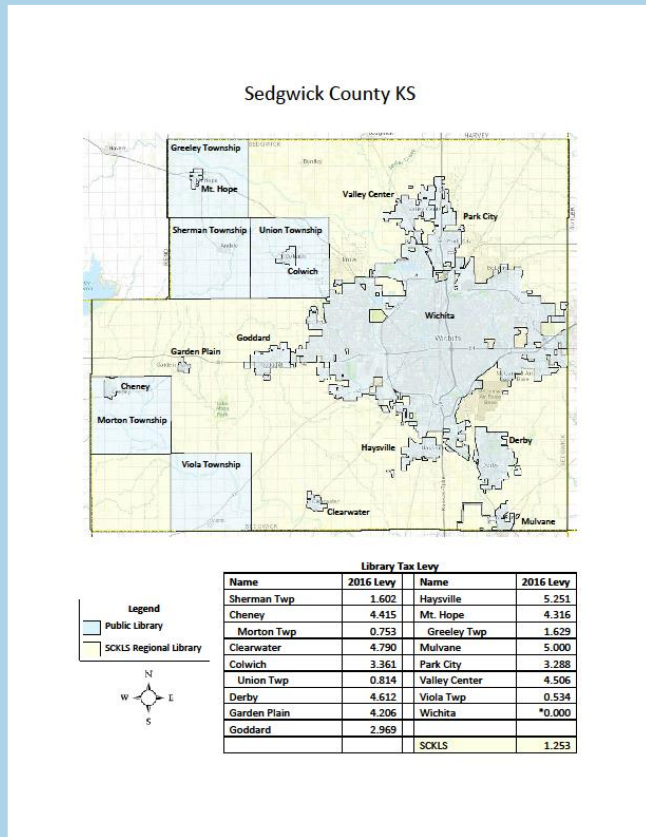
SCKLS Tax and Service Area

Member Library Services to Citizens and Students

In 2017, member public and academic libraries provided access to **93,577 registered library users** who pay the regional library system tax and/or who reside outside an established public library taxing district.

In 2017, member public and academic libraries **interlibrary loaned 59,755** items to requesting libraries on behalf of citizens and students in SCKLS.



SCKLS Grants and Services to Member Libraries

In 2017, SCKLS provided a total of **\$3,660,554 in grants and services** to 144 member public, academic, school district and special libraries.

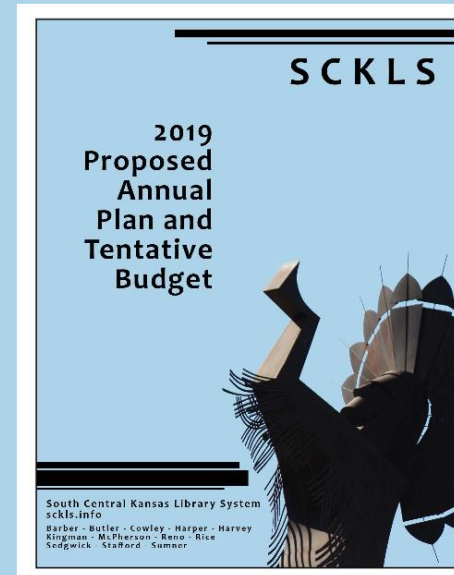

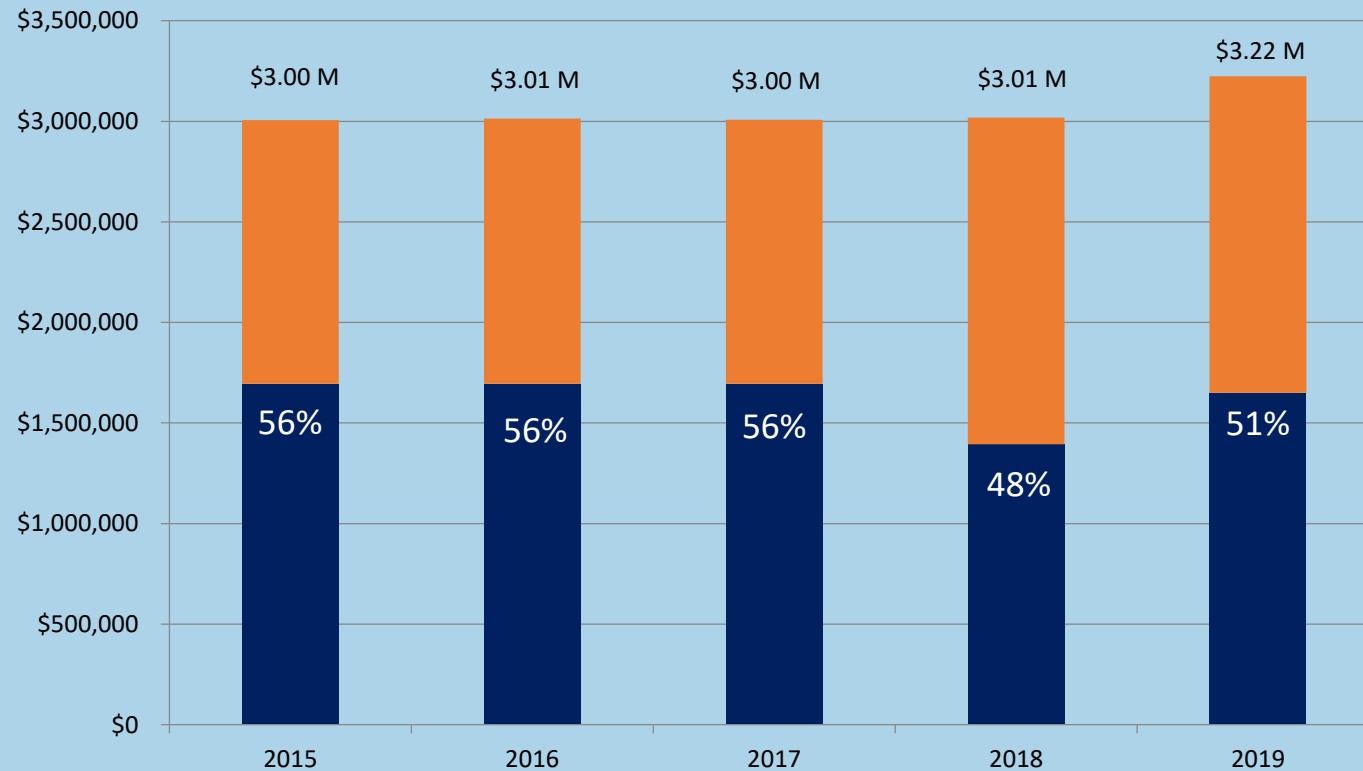

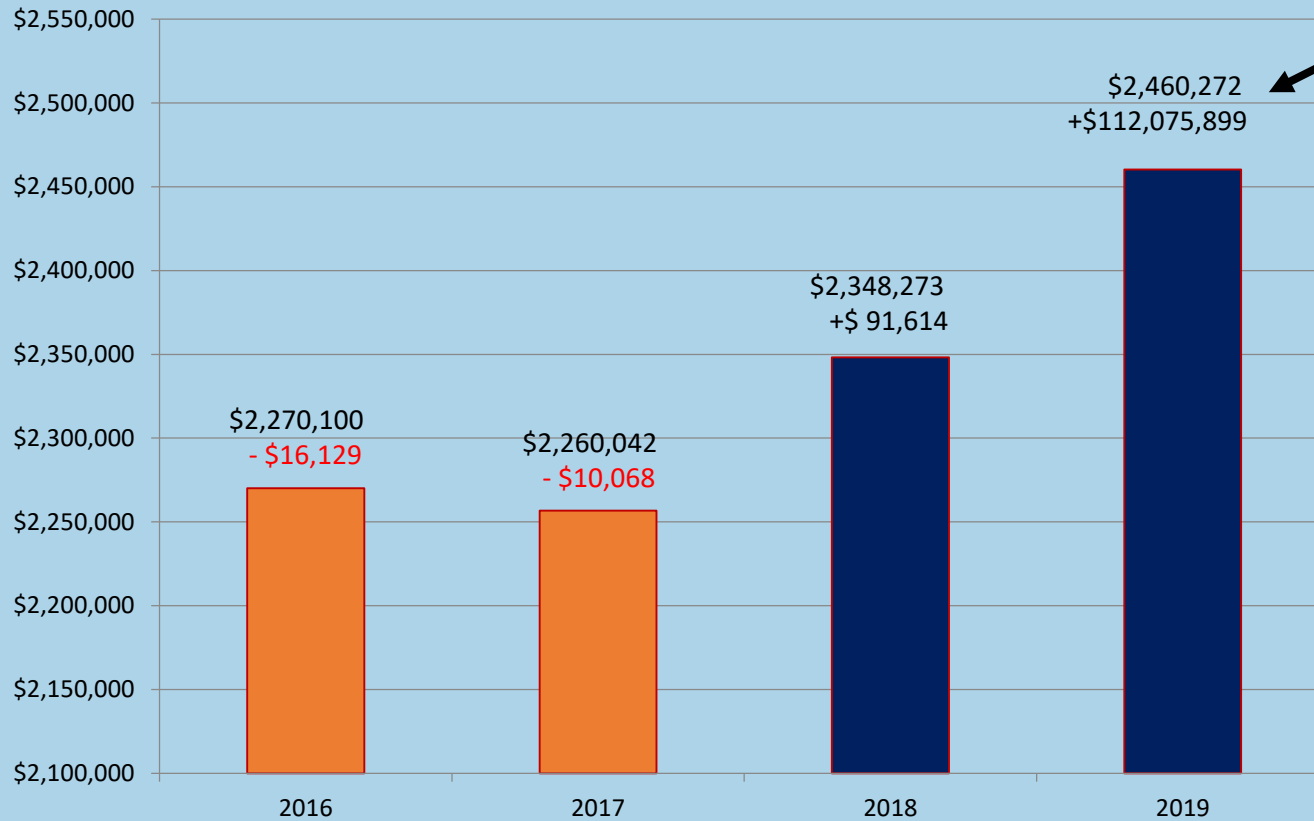

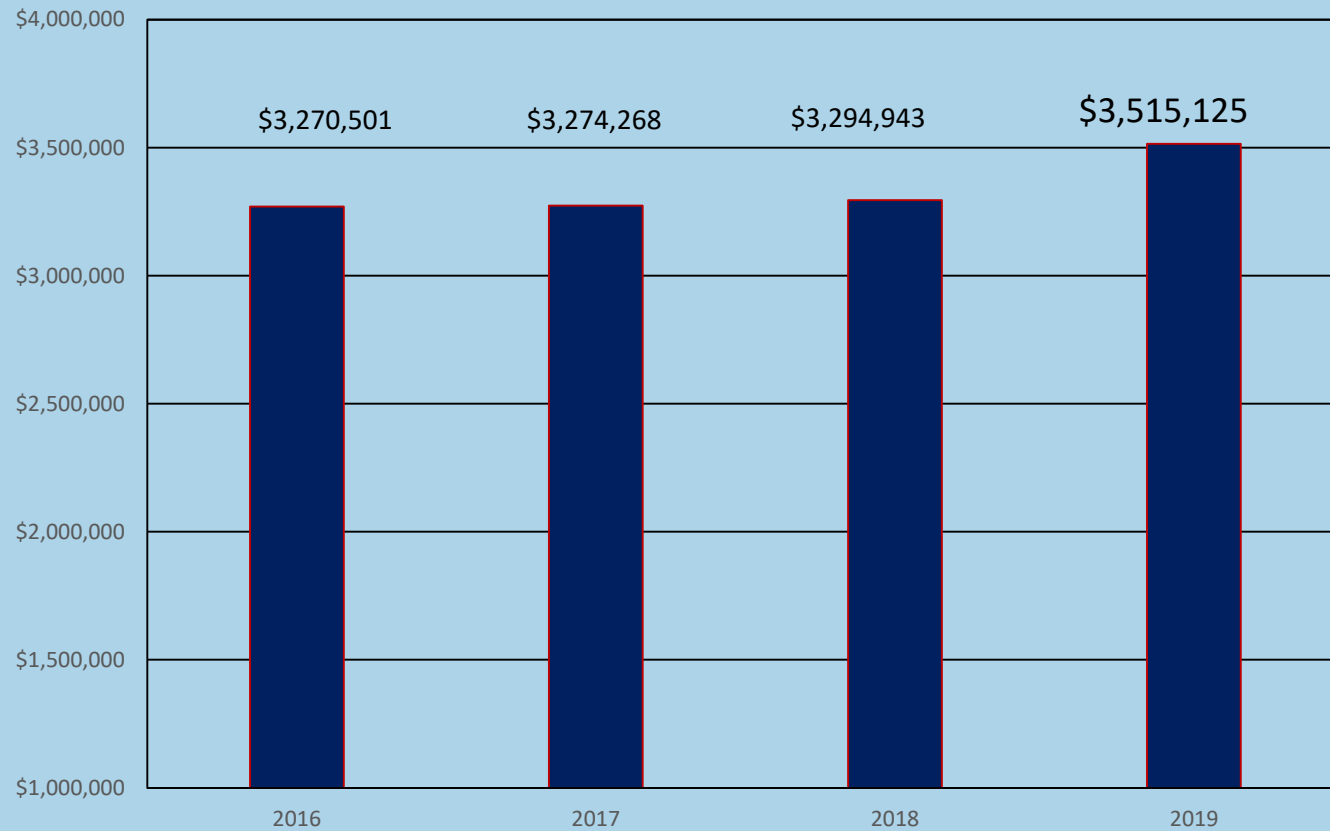
Assessed Valuation of Property

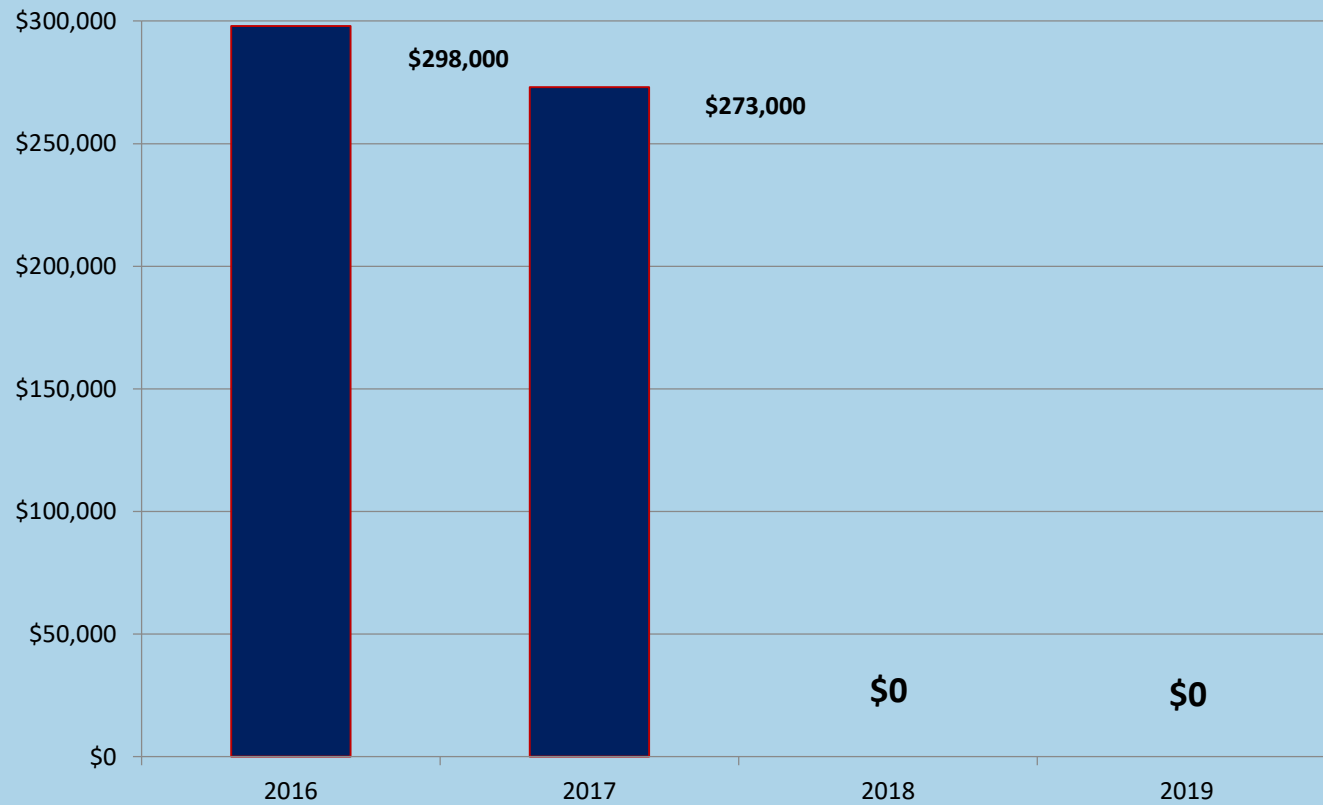


Summary of Significant Assumptions
