Update on House Bill 2176—Paul Hawkins

A written memo was provided with two non-binding, advisory recommendations.

A non-binding, advisory recommendation with respect to the passage by the Kansas Legislature of HB 2176 as amended by the Senate Local Government Committee (March 7, 2024) and subsequent voter

approval of an Arkansas City Area Library District or Udall Area Library District and concerning Kansas Administrative Regulation. 54-1-15. Same: transfer of property.

A motion to approve the recommendation was made by Gail Becker and seconded by Ginger Williams. Discussion followed. The motion was approved.

A non-binding, advisory recommendation with respect to the passage by the Kansas Legislature of HB 2176 as amended by the Senate Local Government Committee (March 7, 2024) and subsequent voter approval of an Arkansas City Area Library District or Udall Area Library District and concerning Kansas Administrative Regulation; 54-1-3 Admission to regional system of cooperating libraries and KAR 54-1-8. Provision for free service.

A motion to amend the draft recommendation and strike the wording "...and to all conditions and terms for the use of grants and services available to a member of the south central Kansas regional system of cooperating libraries [SCKLS]. Such library district shall not be eligible for an annual base grants in aid calculated on population, but shall be eligible for an annual supplemental grants in aid calculated upon the number of registered library users residing outside of the boundaries of such library district and an annual supplemental grant calculated upon the number of interlibrary loan resource sharing provided by the library district." was made by Gail Becker and seconded by Jeff Roberson. Discussion followed.

The motion to amend the recommendation and strike the wording was approved.

A motion to approve the amended recommendation was made by Christina Zenner and seconded by Savannah Ball. The motion to approve the recommendation as amended was approved.

[On the basis of the above Executive Committee actions, a record of the above recommendations that were submitted to the Kansas Senate Committee on Local Government on March 19,2024 has been attached to these minutes.]

Preliminary Information about the 2025 Proposed Annual Plan and Tentative Budget—Paul Hawkins

A written memo was provided. The consensus of the Executive Committee was that the Director prepare two budget options for 2025. Budget A will reflect a minimum estimated loss of property tax income as a consequence of HB 2176 and an 11-12% reduction in the base grants-in-aid for each of the eligible 70 public and 14 academic member libraries. Budget B would address the same minimum estimated loss of property tax and not reduce the grants-in-aid program base grant amounts, but require SCKLS to exceed the Revenue Neutral Rate in order to levy additional tax income.

HB 2176 and South Central Kansas Library System (SCKLS) Recommendations

Dear Senator McGinn:

Eldon Younce, Anthony, who chairs the South Central Kansas Library System (SCKLS) Board and Executive Committee has authorized me to communicate the following two recommendations to you and members of the Senate Local Government Committee. The two non-binding, advisory recommendations were approved by the Executive Committee at their meeting on March 15, 2024.

**Recommendation:** With respect to the passage by the Kansas Legislature of HB 2176 as amended by the Senate Local Government Committee (March 7, 2024) and subsequent voter approval of an Arkansas City Area Library District or Udali Area Library District and in accordance with Kansas Administrative Regulation. 54-1-15. Same: transfer of property.

Upon the date the Arkansas City Public Library or Udall Public Library cease to be members of the south central regional system of cooperating libraries [SCKLS] pursuant HB 2176 and in accordance with Kansas Administrative Regulation 54-1-15 Same: transfer of property, the South Central Kansas Library System Executive Committee recommends the South Central Kansas Library System Executive Committee at the time not require the refund or return of any books, furniture, equipment of other property which has been purchased with south central regional system of cooperating libraries [SCKLS] or state funds.

Recommendation: With respect to the passage by the Kansas Legislature of HB 2176 as amended by the Senate Local Government Committee (March 7, 2024) and subsequent voter approval of an Arkansas City Area Library District or Udall Area Library District and in accordance with Kansas Administrative Regulation 54-1-3 Admission to regional system of cooperating libraries and Kansas Administrative Regulation 54-1-8. Provision for free service.

Upon the Arkansas City Area Library District or Udall Area Library District petitioning to join the south central regional system of cooperating libraries [SCKLS] in accordance with Kansas Administrative Regulation 54-1-3. Admission to regional system of cooperating libraries, the South Central Kansas Library System Executive Committee recommends that the South Central Kansas Library System Executive Committee at the time of such petition make such library district eligible for the services of the South Central Kansas Library System one year from the 1st day of January following the approval of said petition by the State Library Board of Kansas unless financial contribution or other agreement by such library district is agreed upon between the South Central Kansas Library System Executive Committee and the petitioning library district. Such library district shall be subject to KAR 54-1-8 Provision for Free Service.
