WHAT IS COPYRIGHT?

- Copyright is federal law that intentionally creates a monopoly on a creative work for a limited amount of time

WHAT IS COPYRIGHTED?

- Any work that is written down or recorded is copyrighted
- Usually protected until 70 years after the author's death

EXCEPTIONS TO COPYRIGHT

- A limitation on the exclusive rights of the creator of a work.
 - U.S. Copyright Law Sections 107 and 108
 - Fair Use
 - Libraries and Archives

EXCEPTIONS TO COPYRIGHT – FAIR USE

Four factors favoring or opposing fair use

- The purpose and character of the use, including whether it is for commercial use or for nonprofit educational purposes
- The nature of the copyrighted work.
- The amount of the work used.
- The effect of the use on the potential market value of the work.

EXCEPTIONS TO COPYRIGHT – LIBRARIES AND ARCHIVES

A library or archive may make reproduction if:

- You make no more than one copy
- You receive no commercial gain from the copy
- You are open to the general public or researchers
- You include a notice of copyright, or note that the work may be protected under copyright law

COPYRIGHT ISSUES SPECIFIC TO LIBRARIES - REPRODUCTIONS

Reproductions in libraries and archives

- Library user requests for articles and short excerpts.
- Archival reproductions of unpublished works.
- Replacement of lost, damaged or obsolete copies.

COPYRIGHT ISSUES SPECIFIC TO LIBRARIES - REPRODUCTIONS

Posted copyright notice on copiers

- *NOTICE: The copyright law of the United States (Title 17, U.S. Code) governs the making of photocopies or other reproductions of copyrighted materials. The person using this equipment is liable for any infringement.*
- *NOTICE: The making of a copy may be subject to copyright law.*
